Explanation of increases in the budget:

The increase in General Service is to maintain the General Basic maximum levy rate of \$3.50 per \$1,000 of taxable valuation, to complete the restoration and remodel of Marshall County buildings following the 7/19/2018 tornado, support the Marshall County Communications Commission through the county-wide levy, and to maintain necessary fund balances.

The above tax rates do not include county voted levies, mental health and disabilities services levy, debt service levy and the rates of other local jurisdictions.

Regarding proposed maximum dollars, the Board of Supervisors cannot adopt a higher tax asking for these levies following the public hearing.

Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
