**MCCB EQUIPMENT LOAN POLICY**

The Marshall County Conservation Board owns certain equipment available for public use. Cross Country Skis and snowshoes are used for winter recreation and field trips as a means of getting around in the outdoors during the winter for outdoor experiences. Fishing equipment is used for introducing new people to the sport. The Board also has available two 3 pt. hitch Tree Planters, 5 tree planting bars, and a No-till Native Grass Drill.

The equipment will be available free of charge to groups and individuals during MCCB sponsored and co-sponsored events, public programs and field trips. The tree planters and native grass seed drill can be rented to plant habitat for wildlife (see additional TRUAX Rental Agreement Form). At their discretion, the MCCB staff may waive any rental fee.

To use the equipment, the organization or individual must meet these requirements:

Groups or individuals must sign a waiver releasing the MCCB of liability

Groups or individuals must accept responsibility for equipment damages beyond normal wear

Groups or individuals must reserve equipment on a first come first serve through the MCCB Office, [641-752-5490](tel:641-752-5490)

Groups or individuals are responsible for pick up and delivery of the equipment from the MCCB Office at the Grimes Farm and Conservation Center or MCCB Shop facility located at the Central Iowa Fairgrounds during normal business hours, M-F 8:30-4:00 and may borrow the equipment for a maximum of 72 hours

Users of the MCCB Equipment may not use alcohol while using the rented property.

The renter has the responsibility to provide safe instruction to the users on the usage of the rented equipment

## **MCCB EQUIPMENT RENTAL AGREEMENT**

For Use On rent of Cross Country Ski, Snowshoe, Tree Planters, Tree Bars, Native Grass Drill and Other Equipment.

The Marshall County Conservation Board, referred to herein as "OWNER" and \_\_\_\_\_, referred to as "RENTER," agree: Marshall County Conservation Board is the owner of the following personal property:., Cross Country Ski, Snowshoe, Tree Planter, Native Grass Drill(see Rental Agreement for use of Truax Grass Drill) and other \_\_\_\_\_ equipment (circle). OWNER herewith rents to RENTER the personal property described above, for a period of \_\_\_\_\_ to \_\_\_\_\_. RENTER agrees to return the same to OWNER in good condition, ordinary wear excepted.

THIS IS A RENTAL FOR \_\_\_\_\_ PAYMENT FROM BORROWER TO OWNER FOR THE RENTING.

RENTER acknowledges an opportunity to review the personal property rented, and ACCEPTS THE SAME "AS IS," "WITH ALL FAULTS" and WITHOUT WARRANTY. RENTER HAS ASCERTAINED THAT THE RENTED PROPERTY IS FIT FOR THE PURPOSE THAT RENTER DESIRES TO USE THE RENTED PROPERTY.

OWNER is not a "merchant" as the same is defined in the Uniform Commercial Code.

The RENTER agrees to repair or replace any equipment damaged through the misuse or neglect beyond normal wear of the rented property, to not use alcohol or illegal drugs while using rented property and to return equipment within 72 hours to the MCCB.

The RENTER agrees to indemnify and hold harmless OWNER from any and all liability which may accrue as a result of RENTERS use of the bailed property.

The OWNER may terminate this rent prior to the expiration of the same which is specified herein for cause, including but not limited to:

- a. the misuse or neglect of the rented property;
- b. the use of the rented property in contravention of any statute or administrative regulation.
- c. other objectively reasonable cause.

Said termination shall be effective immediately upon Marshall Co. Conservation Board's election to do so.

## **MCCB EQUIPMENT RENTAL FEE SCHEDULE**

- Cross Country Skis; \$5.00/day, \$50 deposit
- Snow shoes; \$5.00/day, \$50 deposit
- Fishing equipment; \$25/rack/day, \$50 deposit
- Tree planter; free of charge, \$100.00 deposit
- Tree planting bar(s); free of charge, \$20.00 deposit
- Truax grass drill; \$10.00/acre or \$25.00 minimum which ever is more (see Truax grass drill rental agreement)
